Class 1: Discuss Chapter 7. **Response Essay 4 Due Tuesday night.**

Class 2: Work on outline in class. **Outline 4 due Thursday night.**

Week of 12/6: **Major Essay 4 Due Monday night (submit smart thinking report at the same time.**

**Late Work, Attendance, and Make Up Work Policies:**

If you want to do well in this course, you should plan to do all of the readings and to attend all class meetings. Failure to attend at least three quarters of all meetings will result in a grade of "W" or "F", depending on whether you were passing. Failure to submit a major essay or a response essay counts as an absence. If you arrive after class has begun you will be counted tardy. Three tardies equal one absence. If you arrive more than 10 minutes late, you will be counted absent. Students use their phones in class will be counted absent.
