Individual instruction in voice or brass, percussion, woodwind, stringed, or keyboard instruments.

Available to non-majors as well as music majors who wish to study a secondary applied emphasis.

Involves one private lesson per week and five practice hours per week. May be repeated for credit.

Methods of Teaching and Learning:

In this course, we will spend time working on solo playing, duet playing, music listening, discussing assignments, creating audio recordings and becoming familiar with standard recording equipment, playing tests and a recital.

Course Objectives and/or Competencies:

The purpose of this course is equip and prepare students with the tools they need to pursue a career in music performing and/or music teaching. Students will spend time on all aspects of trombone playing, including articulation, phrasing, sound quality, beathing, slide technique, and mental approaches to playing the instrument.

Course Outline or Schedule:

Students will be given weekly assignments that will include etudes from method books, sections from the solo repertoire, and listening projects. Specific assignments will be customized to each student, so they will be subject to change based on the recommendations by the instructor.

Course Grading Information:

Students will be graded every week after their lesson (up to 20 points). These grades will be based on attendance, preparedness, and execution of assignments given. Final recital performance will be up to 100 points. In addition, recical attendance will make up the final 5% of students' grade.

Late Work, Attendance, and Make Up Work Policies:

Lesson day and time will be determined at the beginning of the semester. Make-up lessons will be allowed and encouraged in the event that the lesson day and time cannot be met (in person or over the internet, such as FaceTime or Zoom).
