This course explores the history of the theatrical art form from antiquity to 1700. The primary focus of readings and lectures pertains to progression western theatre practices throughout the culture and regions of Europe. In addition, there will be a brief exploration of traditional theatrical methods in Asia. Topics will range from the broad (politics, religion, and society) to the specific (playwrights, actors, costumes, and design).

- 6) Demonstrate writing competence in play report and written exams.

- 3. Play report: Student will select a specific play from the periods covered in the course. The report will summarize the plot and address the key thematic issue while commenting on the historical impact of the work itself.

- 4. Exams: Students will take four exams. Each exam is worth 20% of the total final grade. The lowest exam grade will be dropped. Exams will consist of written essays. Study aids for each exam will be provided during class.
