Individual 1-hour lessons, personal practice, studio class/masterclass, juries

#### **Course Objectives and/or Competencies:**

- Improve technical and interpretive skills at the piano
- Enhance knowledge of classical piano repertoire
- Students will demonstrate mastery of works from the standard keyboard repertoire

#### **Course Outline or Schedule:**

Students will attend one lesson per week and a total of three studio classes. Lesson schedule will be determined in consultation with the instructor. Students must **perform** in one studio class and in the final jury.
