Course Description:

Introduction to musical notation, chords and chord progressions, scales and modes, song forms, intervals and harmonic techniques used in commercial music. Semester Hours 2 (3 lec)

Course Notes and Instructor Recommendations:

Commercial Music Theory I is designed to provide the student with the basic knowledge and skills required to read and write standard musical notation and to communicate, both verbally and in writing, with other musicians using musical notation, terminology and nomenclature. In addition, MUSC 1213 will provide the student with a beginning understanding of **some** of the general principles and theory utilized in the organization of musical concepts (melody, harmony and rhythm) within commercial music styles.

Recommended Additional Resources:

• A thorough knowledge of the piano keyboard is **highly** recommended and will greatly enhance the student's understanding of class material. **Please plan on spending a high** percentage of practice/study time in front of a keyboard.

Methods of Teaching and Learning:

Class meetings will include lecture and in-class assignments relevant to the text and to class lectures. Written homework will be given on a regular basis.

Course Objectives and/or Competencies:

The student will demonstrate proficiency in basic musical knowledge and skills, including:

- Ability to communicate musical ideas using standard musical notation
- Knowledge of major and minor scale construction, key signatures and the circle of fifths
- Knowledge of major, minor, diminished and augmented triad construction and inversions
- Knowledge of diatonic chords within the major and minor scales
- Knowledge of common chord progressions used in commercial music styles
- Knowledge of the modes of the major scale and their relationship to chord progressions
- Knowledge of melodic and harmonic intervals
- Knowledge of melodic and song forms

Course Outline or Schedule:

(Subject to change, students will be notified in class of any changes)

- Unit 1 (wk 1-4) intro to musical notation / basic intervals / accidentals / major scales / key signatures / the circle of fifths / major pentatonic scales / interval quantity and quality / unit 1 test
- Unit 2 (wk 5-7) triads / diatonic triads in major keys / 1-4-5 chord jprogressions / chord inversions / open vs. close position chord voicings / unit 2 test
- Unit 3 (wk 8-11) minor scales, key signatures and the minor circle of fifths / natural, harmonic and melodic minor scales / parallel and relative major and minor scales / diatonic triads in minor keys / modes / chord-mode relationship / unit 3 test

• Unit 4 (wk 12-15) – chromatic intervals / simple and compound intervals / melodic and harmonic intervals / song and melodic forms / final exam

Course Grading Information:

Final grades will be determined by a combination of daily grades, homework and quizzes (80%), and the final exam (20%). A standard numeric scale will be utilized:

90 to
$$100\% = A$$
, 80 to $89\% = B$, etc.

If you have a 92+ average on homework and quizzes, you <u>may</u> be exempt from the final exam (at the discretion of the instructor). Begin thinking about this NOW! Homework must be turned in on time to fulfill this requirement.

Students must complete the course with at least a 70% average in order to receive CMP credit.

Late Work, Attendance, and Make Up Work Policies:

All assignments will incur a 10% deduction for each class period that they are late. Assignments will not be accepted more than two class periods (one week) late.

Quizzes may be given at any time and may include any material covered in class up to that point in the semester. There will be NO make up quizzes or tests without prior notification of an absence. With advance notice of an upcoming absence and at the discretion of the instructor, a test or quiz may be taken prior to the test date.

Student Behavioral Expectations or Conduct Policy:

Students are expected to maintain classroom decorum that includes respect for other students and the instructor, prompt and regular attendance, and an attitude that seeks to take full advantage of the educational opportunity.

- All electronic devices should be silent and put away. Electronic communication of any kind (sending or receiving e-mail, text messages, etc.) during class time will result in the student being asked to leave the class until the next meeting. Any electronic communication sent or received during a test or quiz will result in an automatic F.

- MUSC 2213 is integral to a student's development as a musician. Students must attend class regularly and be prepared to study class material outside of class if they hope to be successful.
