## **Methods of Teaching and Learning:**

Students will receive one hour lesson with the instructor individually per week. The instructor will assign material to be learned by the student for the next week's lesson. The student is required to practice a minimum of one hour per day on the assigned material which will include vocal exercises from the aforementioned text, as well as individual song selections. The teacher will model vocal techniques for the student and accompany the student in the lessons.

# **Course Objectives and/or Competencies:**

The student will learn a minimum of four songs, to be selected by the student and/or the instructor, as well as learn exercises from the text. Students will perform songs from memory and with appropriate stage presence for one studio class and for their jury at the end of the term.

## **Course Outline or Schedule:**

Students will work on assigned exercises, usually averaging one per week from the text and one song selection per week for one hour per day as part of the required practice. The student will build his song repertoire throughout the semester, as well as additional exercises until he has attained mastery of the material assigned.

## **Course Grading Information:**

Students will receive a weekly grade based on their performance of assigned materials. A grade of 85% or more will receive a "plus", and a grade of 70-84% will receive a "check". A grade of less than 70% will receive a "minus". Final grade will be divided into four parts, each counting as 25% of the final grade. They include attendance, songs, exercises and the jury.

## Late Work, Attendance, and Make Up Work Policies:

Attendance will have a large impact on the grade. Each student will be allowed one "free absence". After that, each additional absence will result in automatically lowering the grade by one letter. Instructor may discount the absence if the student has done exemplary work. Students must notify the instructor of an impending absence in advance of the lesson, if at all possible.

Students are expected to maintain classroom decorum that includes respect for other students and the instructor, prompt and regular attendance, and an attitude that seeks to take full advantage of the education opportunity.
