Course Description:

Basic Spanish language skills in listening, speaking, reading, and writing within a cultural framework. Students will acquire the vocabulary and grammatical structures necessary to communicate and comprehend at the beginner level. Semester Hours 4 (3 lec/2 lab)

Prerequisites and/or Corequisites:

No prerequisites are required for this course.

Course Notes and Instructor Recommendations:

Due to the nature of this blended/hybrid course, students must already possess basic computer skills and Internet skills. To complete this course, you must have consistent access to the Internet and a webcam with microphone. Students are required to utilize their MCC email, Zoom, Lockdown Browser with Monitor, and Brightspace in order to complete this online course.

We will cover 11 modules over the course of the semester, and Waymaker allows you to complete up to two modules before paying the \$25 fee. When you take your first and/or second quiz(zes), you will be prompted to register and pay. Methods of Teaching and Learning:

This course includes video tutorials, video discussion board entries, online reading, writing, listening, and speaking activities, online quizzes, online module tests, one cultural research project, and two one-on-one oral interviews with the instructor via Zoom.

Course Objectives and/or Competencies:

This course aims to develop all four aspects of communication in the Spanish language: listening, speaking, reading and writing.

Upon successful completion of this course, students will:

1. Engage in conversations using level-appropriate grammatical structures including narrating events that take place in the present and producing questions and responses on a variety of topics dealing with everyday life.
2. Demonstrate understanding of level-appropriate spoken Spanish.
3. Write simple sentences and organize them into short paragraphs.
4. Read and comprehend level-appropriate texts.
5. Identify and discuss traditions, customs and values of the Hispanic world.
6. Compare and contrast the traditions, customs and values of the Hispanic world with characteristics of their own culture.

The Texas Higher Education Coordinating Board requires that all courses in the Foundational Component area of Language, Philosophy, and Culture teach these Core Objectives:

- **Critical Thinking Skills (CT):** “to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information.”
- **Communication Skills (COMM):** “to include effective development, interpretation and expression of ideas through written, oral and visual communication.”
- **Social Responsibility (SR):** “to include intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities.”
- **Personal Responsibility (PR):** “to include the ability to connect choices, actions and consequences to ethical decision-making.”

Course Grading Information:

The grade for this course will come from the following components:

- *Online Tests:* 4 tests, taken online via Brightspace, utilizing a webcam monitoring program to ensure academic integrity (Lockdown Browser with Monitor). Please note that due to the comprehensive nature of language learning, each module builds on prior learning. For that reason, it is extremely important to study regularly and to continuously review older material. If you try to wait until the last minute and cram for a test, the material is not likely to make it into long-term memory, which will make it very difficult to do well as the semester progresses.

- *Oral Interviews:* 2 one-on-one oral interviews with the instructor (one midterm and one final), lasting approximately 5-8 minutes each, conducted via Zoom. Students will be provided with all of the questions they might be asked in advance. Questions are designed for students to demonstrate mastery of vocabulary and grammar lessons studied, and students will be graded on comprehension, grammatical accuracy, use of complete sentences, fluency, and pronunciation. A detailed grading rubric will be posted in the oral exams content folder in Brightspace.
- *Discussion Board Video Posts:* Students will respond orally via “videonote” to discussion questions related to the unit vocabulary by posting a video, and then respond in writing to at least two classmates’ posts for each discussion assignment. There will be 4 discussion videos assigned throughout the semester.
- *Online Study Plans* (11) For each module, students will read all information and complete activities in a “study plan.” Each study plan contains four or five “dive in” boxes, and the last activity in each “dive in” box is labeled “self-check.” For each “self-check” completed, students will earn 20%-25% (depending on whether there are 4 or 5 boxes). The self-checks are graded based on completion (not accuracy), and are intended to help the student gauge their understanding of the content before taking a quiz. Completing the study plans/self-checks on schedule impacts both this portion of the student’s grade *and* the attendance and participation portion.
- *Online Quizzes:* (11 each) After viewing and completing all other content in each module, students will take a module quiz. The quizzes *are* graded for accuracy. Students will have two attempts per quiz, and the highest grade for each quiz will be recorded. I strongly encourage budgeting enough time in between attempts to be able to go back and study the concepts missed on the first attempt before making the second attempt.
- *Oral Presentation:* Students will give one live, oral presentation related to Hispanic culture in which they will demonstrate the ability to speak fluently in the target language for 2-3 minutes. Requirements and grading criteria will be shared via Brightspace at least three weeks prior to scheduled presentations.
- *Attendance & Participation:* To earn full attendance and participation points, students must attend class regularly and punctually, participate actively (effort counts for a lot!), view all digital content assigned, meet all due dates for assignments and assessments, respond to all discussion boards, and take advantage of opportunities to receive formative feedback (e.g., utilizing office hours if there’s a concept you’re struggling with, and/or submitting rough drafts of work for feedback before assignments are due).

Grades will be weighted as follows:

Detailed grading rubrics will be provided via Brightspace for oral interviews and discussion board videos. Major tests will be graded objectively for accurate use of Spanish vocabulary and grammar.

Final grades will be distributed according to the following scale:

A = 90 and above B = 80 to 89.99 C = 70 to 79.99 D = 60 to 69.99

F = Below 60

Late Work, Attendance, and Make-up Work Policies:

The instructor will follow the official MCC Attendance/Absence policy posted in the Highlander Guide. Students who are forced to miss a deadline or class meeting for reasons beyond their control are expected to communicate with the professor (in advance if possible, and no later than 24 hours after the missed class or deadline if advance notice is not possible) to discuss the possibility of make-up work. Students who fail to complete 25% of all assignments, or who miss more than 8 days of class / 4 weeks of work prior to the 60% point in the semester will be withdrawn from the class. After the 60% point, students who fail to attend at least 75% of all classes will receive a grade of F.

*Note: Under normal circumstances, I only accept late work in the case of officially excused absences. Given the unusual circumstances resulting from the COVID-19 pandemic, I will err on the side of caution this semester and be more flexible than normal; however, *it is imperative that students be proactive in communicating with me about their attendance and participation.* Late work will not be accepted without a reasonable excuse and proactive communication.

- No eating or chewing gum in class, please. I will frequently call on students at random, and having food or gum in your mouth will impede your ability to respond appropriately.
- My goal is to create a friendly, encouraging, and productive atmosphere in which students feel safe to participate. Therefore, I expect students to receive and provide feedback to and from the instructor and one another with a positive attitude in the interest of learning.
- Students should be aware that successful completion of this course will require a great deal of self-discipline and integrity. **Academic dishonesty (cheating) will not be tolerated.** While you may use notes/vocab lists/etc. while completing the study plans and quizzes, NO RESOURCES (including, but not limited to notes, textbooks, dictionaries, cell phones, or any form of translation assistance) may be used when taking tests or oral exams. Beware that if a student is caught cheating on a test or oral exam, the grade for that test will be a 0, the student will be reported to the Department of Student Conduct, and all prior and future test-taking video footage will be carefully reviewed. If a second offense is observed—whether it was committed before or after the first offense—the student will be dropped from the course with a grade of F.

*Note: My intention in using bold, capitalized, and underlined text above is not to come across as threatening; however, I sincerely believe academic integrity is important, and I want to make it clear that the consequences outweigh the benefits of cheating in this class, as the course is structured to provide many opportunities to succeed through effort and participation.
