#### Methods of Teaching and Learning, Course Objectives and/or Competencies:

- To develop basic clay construction skills
- To become familiar with clay materials and glaze application
- To introduce kiln loading and firing processes in electric and gas kilns

- To critically evaluate ceramic work, individually and in a group
- To explore ceramics, past and present, for illustration of technique and examples of aesthetic

#### **Course Outline or Schedule:**

Class meets on Tuesdays and Thursdays from 1 to 4. Project due dates, demonstrations, firing schedules, and critiques will be posted on the calendar in the classroom. Demonstrations and critiques cannot be made up.

#### **Course Grading Information:**

There will be various projects given throughout the semester. Your grade will be based on the craftsmanship, creativity, and effort devoted to projects as well as your participation in class and maintenance of the studio. Assessments will be averaged together for your final semester grade.

# **Course Attendance/Participation Guidelines:**

If a student is not in attendance in accordance with the policies/guidelines of the class as outlined in the course syllabus as of the course census date, faculty are required to drop students from their class roster prior to certifying the respective class roster. A student's financial aid will be re-evaluated accordingly and the student will only receive funding for those courses attended as of the course census date.

Before the 60% point of the semester, a student who is absent for 25% or more of a face-to-face or blended course or who misses 25% or more of assigned work for an online course will be withdrawn from the course with a grade of W. A student may also request to be withdrawn with a grade of W before the 60% point of the semester. After the 60% point of the semester, the student may request to be withdrawn if the student is passing, or be assigned the final grade earned at the end of the semester after grades have been updated to reflect missing work

#### Late Work, Attendance, and Make Up Work Policies:

This class meets twice a week for three hours each day. Demonstrations and lectures could be presented at any time, so it is essential that you attend class regularly and on time. Attendance will be taken immediately at the start of class; you must arrive on time and stay through the end of class to be counted present. Students who may be present yet are not actively participating in classwork will be counted absent. If a student is tardy to class three times, it will count as one absence. After three tardies, your classroom

privileges may be revoked. All absences, for any reason, are treated equally. You are responsible for catching up on missed material. If you miss more than 25% of the total classes (7 classes) you may be dropped or receive a failing grade.

Assignments and projects are based on information discussed in class, so attendance is essential. Though time will be given during class for work on projects, you will need to spend extra time in the studio outside of class. Consider this your homework. Late work is not accepted.

The last day to drop this class is October 27, 2022. After that date, you will receive a grade for this course, whatever that may be.

#### Student Behavioral Expectations or Conduct Policy:

Students are expected to maintain classroom decorum that includes respect for other students and the instructor, prompt and regular attendance, and an attitude that seeks to take full advantage of the education opportunity. Studio maintenance and cleanup is required.
