#### CMSW 1323 – The Exceptional Person:

Study of physical, intellectual, and learning disabilities, sensory deficits, and the exceptionally gifted individual throughout the lifespan. #### Methods of Teaching and Learning:

All of the course material will be delivered via the internet. The required text book is needed to complete the course. Students will have a weekly reading assignment from the text book. They will need to respond to a Discussion Board (Db) assignment from each chapter. They will also take an online quiz for each chapter. Students will complete a semester project paper on a topic of their choosing that is related to the course.

Students will earn points on each completed assignment. The total points earned during the semester will determine the student's final grade. More information about the grading system is provided later in the syllabus.

Students will need to allow regular weekly time to read the assigned material and complete the assignments. A reasonable level of self-discipline is needed for successful completion of the course.

Since the course is totally constructed around online participation, the student should have knowledge of using a Web browser, computer, and e-mail: the ability to create and save documents; the ability to send and receive electronic documents; and a general understanding of online technologies and appropriate online behavior. The basic MCC Computer requirements are:

#### **Course Objectives and/or Competencies:**

Students will identify various handicapping conditions of children and adults. They will define these conditions, list their symptoms, and describe treatment options.

By the end of the semester the student will be able to:

- 1. Discuss limitations and strengths associated with exceptional abilities or disability or disabilities.
- 2. Assess their own feelings concerning persons with special needs by gaining a better understanding of them through participation in class and outside activities.
- 3. Understand the significance of perception and its role in attitude and adjustment of like skills.
- 4. Describe public laws and their significance to persons with special needs.
- 5. Map the historical social attitudes toward persons with special need.
- 6. Compare the general categories of handicapping conditions,
- 7. Compare/contrast symptoms and possible causes of the handicapping conditions.
- 8. Identify appropriate interventions for the handicapping conditions.
- 9. Identify services for persons with special needs.
- 10. Discuss the concept of the giftedness and how it is addressed in the educational environment.

Since this is an introductory/survey course, these competencies will be evaluated through examinations designed to measure the student's acquisition of these competencies

This course is part of the Mental Health Program. To view the list of program learning outcomes, go to the end of the syllabus and view Program Learning Outcomes for Selected Courses.

#### **Course Attendance/Participation Guidelines:**

I-Incomplete-this grade is given when a course is incomplete because a student's absence is caused by illness, or other reasons acceptable to the instructor, prevents the student from completing the required projects of the course. To be eligible, the student must have essentially completed the course. The work remaining should be of such nature as not to require class attendance. If the work is not made up within the following long semester, the "I" will be changed to an "F" and the course must

be repeated if credit is to be given.

#### Withdrawal

Students who are considering withdrawing from a course are to contact one of the following, preferably in the order listed: instructor, program director, division chair or advisor. If, after consultation between the student and the instructor, there is a decision to withdraw through the 60 percent point in the semester or term, **it is the responsibility of the student to see that the Change in Schedule Form is completed and submitted to** <u>Highlander Central</u>.(The instructor can also process a withdrawal from a course through WebAdvisor.) The student should check WebAdvisor to verify that the withdrawal was processed.

If, after the 60 percent point in the semester or term and after consultation between the student and the instructor, there is a decision to withdraw, it is the responsibility of the instructor to submit the Change in Schedule Form to <u>Highlander Central</u> or process a withdrawal through WebAdvisor as soon as possible or prior to the last class day of a semester or term. The student should check WebAdvisor to verify the withdrawal was processed. The effective date for withdrawing from a course is the date the withdrawal is processed.

<u>Quizzes:</u> There will be 15 quizzes during the semester, but the instructor reserves the right to vary this number as needed. Each chapter will have a quiz that will be composed of 20 randomly selected multiple-choice or True/False questions. <u>You must take each unit's quiz no later than 11:55pm on the due date</u>. After this time the quiz shuts off and you will not be able to access it. Your grade will be a zero (0) for that quiz. This is a timed test and you will have 25 minutes to complete all of the questions. You will have one chance to take this quiz. Make sure that you are ready to take the quiz before you hit the **Begin** button. Once you do this, the clock will start and you will need to begin answering questions. \*If you go less than 5 minutes over the time limit, you will have 2 points deducted from your score; less than 10 minutes over the time limit you will have 4 points deducted from your score; 10 minutes or more over the time limit and you will receive a 0 as your score.\*

<u>Project Paper:</u> The project will be worth 100 points. See the project guidelines at the end of the syllabus. The project paper is due <u>no later than the due date at 11:55pm.</u>

## \* The paper cannot be submitted as a hard copy or an email attachment. It has to be submitted in Brightspace.

It is expected that the paper you submit for this class is one that was written solely for this class and not for another class. To write a paper and submit it for a grade in two different classes is highly unethical. Students caught doing this will receive a zero (0) for this assignment.

<u>Discussion Board (Db)</u>: Each week there will be a different Db question for you to consider. You are asked to post on Db your well thought out response to the question. You are also asked to post responses to two of your fellow students' posts. Everything you post on Db needs to have appropriate content and be constructive in nature. A simple statement such as, "I agree" or "You're right" is not sufficient. Avoid posting in ALL CAPS as this looks like YOU ARE YELLING at the other student. In addition, please <u>do not use "text-speak"</u> such as LOL, BFF, etc. Students who do an excellent job of contributing will receive the full 10 possible points each week. Students who contribute less will receive less. Students who do not provide all 3 postings each week will receive 0 points regardless of their content.

#### Late Work, Attendance, and Make-Up Work Policies:

Late Work

Acceptance of late work is at the discretion of the instructor. Late project papers accepted will receive a 10 point deduction if turned in up to 1 week late; 20 point deduction if turned in up to 2 weeks late. Any project paper turned in after 2 weeks of the assigned date will receive a grade of zero (0). All quizzes must be taken within the 25-minute time limit. \*If you go less than 5 minutes over the time limit, you will have 2 points deducted from your score; less than 10 minutes over the time limit you will have 4 points deducted from your score; 10 minutes or more over the time limit and you will receive a 0 as your score.

You must take each unit's quiz no later than the due date at 11:55pm. After this time the quiz shuts off and you will not be able to access it. Your grade will be a zero (0) for that quiz.

\*\*It is acceptable to submit a project paper to me before the day it is due. This will prevent points from being deducted if you are unable to send it to me on the due date.\*\*

#### Quizzes and Db

All quizzes and Db are open and available to students on the first day of the semester. Students have plenty of time to complete the quiz and Db for each unit. Therefore, students should not have any reason to submit a quiz and/or Db after the due date. When students wait until the last few hours to complete these assignments, they run the risk of "my internet quit," or "I had to work late," or "I have been sick."

Ethics

Cheating will not be tolerated. Any student found to be cheating will be subject to grade reduction, re-doing of assignment, and/or dismissed from the course. Example of cheating include but not limited to:

• Coping the work of another student

- Seeking excused absences/tardies under false pretense

#### The Exceptional Person CMSW 1323 Project Paper Guidelines

The project for this class is to write a paper regarding a particular disability or disease. You may select any one that is in the text book. If there is one that you have a particular interest in that is not in the text book, please e-mail your instructor to get permission to use it.

Your paper should contain:

- 1. Description of the particular disability or disease including
  - a. causes (if known)
  - b. physical description (if that applies)
  - c. other characteristics (behavioral, emotional, etc.) commonly related to this disability or disease
- 2. Challenges that this creates for families and schools
- 3. Effective techniques for working with this challenge
  - a. at home
  - b. at school/work
  - c. in any other areas
- 4. Research that is being done to improve or eliminate this disease or disability
- 5. Local, state and national resources available to assist individuals and families dealing with this disorder or disease
- 6. How you intend to use this information in your career

Your paper should be at least 5 <u>type-written</u>, double-spaced pages. If it is less than 5 pages you will lose significant points. Use at least three resources (journal articles, books, etc.) other than your textbook and document the sources of your information in your Bibliography. The Bibliography needs to contain the name of the source, the author and the date of the article. You can access journal articles online through the MCC Library:

http://www.mclennan.edu/library/ Articles & books should have been written within the last 2-5 years. The Bibliography should be included at the end of your paper. (The Bibliography does not count as one of the 5 pages.) Not including a Bibliography page is considered plagiarism and will result in a failing grade on the paper.

Since this is not a formal research paper, I do not expect you to include citations, APA or MLA writing styles. However, I do expect you to write the entire paper in your own words. If you copy information word for word from the articles and put it in your paper without saying that someone else wrote it, this is called **plagiarism**. If you do this you will fail the assignment, at a minimum.

Spelling and grammar will be a part of your grade. I expect everything to be spelled correctly, be in complete sentences, and display understanding of the material. It is a good idea to have someone proof-read your paper – Spell Check <u>will not</u> catch all of the mistakes. I will be looking for complete sentences. Also, please do not use contractions in a paper like this.

There are two objectives for this assignment:

- Learn more information about the topic you choose.
- Demonstrate your ability to communicate this information in a written format that is clear and understandable to the reader.

The paper should be submitted to your instructor on Brightspace <u>no later</u> than 11:59pm on the due date. These procedures are explained in the Project Paper folder in the Assignments section. Papers received after this time will be subject to the <u>Late Work</u> policy.

A rubric used to grade this assignment will be posted on Brightspace to assist in your writing and formation of your paper.

#### **Extra Credit Option**

Working in the Social Work or Mental Health profession requires the ability to communicate clearly and effectively in written format. This can take the form of admission reports, daily progress notes, case summaries, case reviews, discharge summaries, etc. Your performance on the job will be evaluated not only on your direct contact with clients, but also in how well you write.

With that in mind, you may earn 5 extra points on your written paper for this course by going to Academic Support & Tutoring and taking advantage of one of their tutorials on a topic of your choosing. Or you may choose to have them look at your paper before turning it in to your instructor. This would give you the opportunity to make any corrections that they may suggest. The staff will provide you with documentation that you participated in their services. You will need to turn this documentation in to your instructor when you turn in your completed written project paper.

If you are not able to come to campus, you may still earn this extra credit by e-mailing a draft of your paper to Academic Support & Tutoring. They will then return the paper to you with feedback. When you submit your final paper to your instructor, you will also forward the e-mail from them as verification that you participated in their services.
