

Course grades are firm and will not be "curved" or "bumped." **Grades are based on actual performance, not amount of effort exerted, potential, hardships encountered during the semester, etc.** There is <u>no</u> extra credit in this course. In order to earn a C or above, students must stay current with readings and assignments and exhibit strong class performance.

A minimum final grade of C is required in all Mental Health/Social Work classes for graduation.

I INCOMPLETE - is given when a course is incomplete because of a student's absence caused by reasons acceptable to the instructor. To be eligible, the student must have essentially completed the course. If work is not made up within the following long semester, the "I" will be changed to and "F" and the course must be repeated if credit is to be given.

Late Work and Make Up Work Policies:

No late work will be accepted in this class unless this professor determines that the student's absence was due to an unavoidable emergency. This professor determines what an unavoidable emergency is. Any late work accepted will earn an automatic 10 pt deduction. All work not turned in by the due date will receive a "0." Students will be counted absent from class meetings missed, beginning with the first official day of classes. Course Assignments:

Quizzes

Each student will take a quiz at the end of each Chapter (this includes the Orientation Chapter). This means that there are a total of 14 quizzes (and orientation quiz one quiz per chapter). Each quiz will consist of Multiple Choice and True/False questions. All quizzes have 20 questions and you will have 30 minutes for each quiz. It is extremely important that you STUDY for each quiz. You get ONE CHANCE to take each quiz. I will NOT provide study guides for these quizzes. I take quiz questions from the textbook, power points, videos, and articles provided. I HIGHLY SUGGEST that you read each chapter to make sure that you are understanding the power points. These quizzes are not easy. Since there are weekly quizzes, there will be no exams (mid-term, final, etc).

Discussion Boards

Discussion boards are a way that the Professor can make sure that students are understanding the material. Discussion boards are also a useful tool to ensure that there is classroom discussion in an on-line format. Each week, students will respond to discussion board posts weekly. You will not see any of your classmates threads until you have posted one. After you have made your post, you will see your classmates threads. You have to answer the original Db question and reply to at least two other students' posts to get any credit. Anything less than 3 posts will earn zero (0) points. To earn a top score (100%), the student must do an original post and thoughtfully respond to at least 2 of your peers. Writing a couple of sentences in a post will NOT earn you a high score. To earn a high score on a discussion board, the student must write at least 10 sentences (in each post). My expectation is that ALL STUDENTS be respectful to each other when they make posts. Chapter 3 Reflection Paper

Reflection papers are an opportunity for you to demonstrate your ability to critically think about and apply the course material. Please make sure that you read and understand all of the instructions.

To Start.....

- 1. Read Marijuana Tax Act of 1937 (pages 49-51). This will help you in writing your response paper.
- 2. Read the Case Study on Alamosa Daily Courier (page 49 in the textbook).

Use the following headings and give your responses by using your own words and research. Your paper will be graded partially based upon the inclusion of ALL points below. Please make sure you address each prompt:

- 1. Why was the Marijuana Tax Act of 1937 passed?
- 2. Explain why the 1936 movie, Reefer Madness, was considered an American propaganda film about drugs.
- 3. Why was the American Medical Association critical of the passage of the Marijuana Tax Act of 1937?
- 4. After reviewing the Alamosa Daily Courier case study (on page 49 of the textbook), please respond to the following prompts:
- a. How does this editorial speak the racial undertones of the times?
- b. What facts does his article bring forward? What about opinions?
- c. How does this article use fear to encourage action?

Response papers must meet the following criteria:

- APA format (this includes cover page and reference page)
- Typed
- Double-spaced
- 12-point font
- Times New Roman
- 1-inch margins
- 3 pages long (no more than 5 pages) If the reflection paper is less than 3 pages, there will be a

MAJOR point deduction.

• A total of 2 references: 1 textbook reference and 1 reference from another periodical

It is really important to follow all of the prompts listed below. Failure to do so will result in a MAJOR point deduction.

It is also important to write in a narrative format. I do NOT want a question/answer style when you write the paper. It is perfectly acceptable to use headings. In fact, I prefer it. It makes it easier for me to read!

Grammar/punctuation/sentence structure: The use of proper grammar, punctuation, and sentence structure is extremely important in college and when one enters the workforce. Good grammar keeps your readers or listeners focused on what you have to say, not on how you are saying it or why you are making mistakes. 1. <u>Summary:</u> Tell me in 1 or 2 paragraphs what the documentary was about. This part should NOT take up the bulk of your paper.

(Most of your paper should consist of points 2 and 3)

- 2. <u>New Information Learned</u>: Tell me 3 or more things you learned from the documentary that you did not know before. Be specific and explain your points. How can you use this knowledge? How will this new knowledge impact your future career?
- 3. <u>Prior Knowledge</u>: Tell me 3 or more things you already knew and that the documentary confirmed.

Use double-spaced, 12-point, Times New Roman font. This review should be 2-3 pages and must be submitted via Brightspace. This means there must be a MINIMUM of 2 pages. Any paper submitted that is less than 2 pages will earn a MAJOR point deduction.

Grammar/punctuation/sentence structure: The use of proper grammar, punctuation, and sentence structure is extremely important in college and when one enters the workforce.
