Methods of Teaching and Learning:

- 3. Develop and implement a safe plan for managing an acutely injured combative patient;
- 4. Demonstrate proper body mechanics and utilize appropriate tools to properly extricate a patient in a confined space or damaged vehicle; and
- 5. Communicate effectively with the patient, family, and healthcare team members.

Course Attendance/Participation Guidelines:

If a student is not in attendance in accordance with the policies/guidelines of the class as outlined in the course syllabus as of the course census date, faculty are required to drop students from their class roster prior to certifying the respective class roster. A student's financial aid will be re-evaluated accordingly, and the student will only receive funding for those courses attended as of the course census date.

Course Outline or Schedule:

EMSP 1173_78 will be offered for the EMT students twice a week, on Tuesdays and Thursdays. Course topics begin with introducing the mechanics of moving and lifting patients safely. Emphasis is on building core strength and flexibility. Students will focus on using proper body mechanics and selecting and using appropriate materials and equipment to assist the patient. Students will be challenged to improve strength, cardiovascular endurance, and flexibility.

Course Grading Information:

Students will be awarded credit for attending each class and participating in the entire session.

Late work is not accepted. Alternate assignments will be given for partial.
