#### Course Description:

Provides private instruction in guitar with goals related to a career in the music industry. The student will demonstrate proficiency in commercial music repertoire and technique; develop a professional, disciplined approach in performance skills, and present a juried performance for faculty. If the student is considered to be at the appropriate level of proficiency by the instructor, the juried performance will be a capstone recital for faculty and students.

#### Prerequisites and/or Corequisites:

Corequisite: concurrent enrollment in a Commercial Music Ensemble – exceptions must be approved by program director.

#### **Course Notes and Instructor Recommendations:**

It is recommended that students keep a practice journal in which practice time, material practiced, questions and observations are logged.

A jury will be played at the semester's end for the string faculty. This will demonstrate the work done and progress achieved during the semester. Scales, arpeggios, chord studies and several songs will need to be prepared for this event.

Students are required to practice <u>at least</u> one hour per day. Guitar majors should set aside time to practice 2 hours per day.

Students are also required to submit 5 written reviews of MCC Music or Music Industry Careers ensembles (in which they did NOT perform) throughout the semester. An outline/format for written reviews will be provided.

It is highly recommend that students purchase a metronome and an electronic tuner. These items can be found at any music store or online for anywhere from \$20.00 to \$50.00 or more.

#### Methods of Teaching and Learning:

Projects, student performances / presentations, exams, quizzes.

#### Course Objectives and/or Competencies:

To develop the skills necessary to work as a professional guitarist by learning to:

- 1) play a variety of accompaniment styles.
- 2) improvise using scales and arpeggio patterns combined with knowledge of chord-scale relationships.
- 3) read chord charts and melody lines.
- 4) play a continually expanding repertoire of songs.

#### **Course Outline or Schedule:**

Weekly grades will be given based on the student's preparation for and progress toward the goals assigned at each weekly lesson, which are dependent on the student's individual skill levels.
