# **Course Description**:

Emphasizes critical thinking and problem-solving skills. Topics may include set theory, logic, number systems, number theory, functions, introductory probability and statistics, and the application of these concepts to real-world problems.

#### **Prerequisites and/or Corequisites:**

Minimum TSI math score of 328-341 or TSI ABE level 5 or 6: or credit in BASM 0300, Math 0301, or its equivalent, or approval by the Division Chair.

#### **Course Notes and Instructor Recommendations:**

Math 1332 in an online, linked, face/face, or hybrid format all involve online homework assignments and some online testing. Everything is available online including an electronic version of the text, class notes, and both publisher and instructor lecture videos. There are numerous other learning aids available at the online site. Online classes require no campus attendance. Hybrid classes require some classroom attendance. See the semester schedule for specific hybrid attendance requirements.

### **Methods of Teaching and Learning:**

This course is designated as blended this semester. That means that the class will physically meet on certain days, but online lessons will be provided with video lectures and notes on other days. If the class size dictates the need to ensure safe social distancing, the class will be divided into 2 groups (cohorts). I will designate them as group A and group B. Students will be informed by email and/or phone call prior to the start of the semester about which group they are assigned. It is important that students only attend on their designated days. Group A will attend class in-person on Mon and Wed while Group B will attend on Tue and Thu. Ideally you would attend all 4 days together, but in this blended format you will do a % of the lessons by watching lecture videos and using available lecture notes. You will be responsible for online homework and online tests as noted in the calendar. If conditions dictate a need to go completely online, then all assignments will be presented in the online format and the weekly assignments will be completed without attending the class. MyMathLab is the online component that will house the course information and it will be accessed via Brightspace. You will be informed prior to the first class meeting if the need for cohorts is indicated.

# **Course Objectives and/or Competencies:**

Students successfully completing Contemporary Mathematics should be able to:

- 1. Solve problems using critical thinking and reasoning skills. (1,2,3,4,5,9)
- 2. Evaluate and appreciate the structure, beauty, power of logic and deductive reasoning (1,2,3,9)
- 3. Utilize various strategies (making a drawing, table, graph, etc.) for problem solving.(1,2,4,5,9)
- 4. Compute loan payments, credit card charges, mortgages, and investments. (1,4)
- 5. Real world analysis of data and information using probability and statistics to summarize, interpret, or predict. (1,2,5)
- 6. Graph and interpret data in appropriate form to present a visual relationship of data sets in real life. (1,2,5)
- 7. Introductory treatment of sets, logic, number systems, number theory, relations or functions. (2,3)
- 8. Using technology to enhance algebraic and statistical concepts. (1,2,4,5)

## **Course Grading Information Math 0308:**

Grading in this course (Credit or No Credit) will be based on attendance and passing Math 0308 computer lab activities assigned by the instructor. Failure to meet the attendance and participation requirement may result in either being dropped from both Math 0308 and Math 1332 or earning NC (no credit) in the developmental course, Math 0308.

#### **Course Grading Information Math 1332:**

Grading in this course will be based on homework, unit tests, and a comprehensive final exam according to the following percentages.

Online homework ave: 25% or 30%

Test average: 50%

Before each test is available (online or face to face), all homework assignments must be completed with at least a 70% score for that unit. Makeup tests will not be given.

Communication Project: 5% (IF APPLICABLE)

Final exam grade: 20%

Having someone else do your online homework assignment and cheating on a test are both violations of the academic integrity policy and either may result in failing grades and/or being dropped from the class. Infractions such as these will be reported to the administration for tracking and possible college action.

### Late Work, Attendance, and Make Up Work Policies:

In this blended class, there are expectations of doing assignments whether you attend class or are absent. Although there will be F-F lectures, a % of the lessons will be taught in a video lecture format. Whether you meet the class or are in a remote setting, homework and tests that are listed in the weekly calendar should be completed by the end of each week.
