This course explores the history of the theatrical art form from the early 1700s to the modern times. The primary focus of readings and lectures pertains to progression western theatre practices throughout the culture and regions of Europe. In addition, there will be a brief exploration of traditional theatrical methods in Asia. Topics will range from the broad (politics, religion, and society) to the specific (playwrights, actors, costumes, and design).

### **Course Outline or Schedule:**

### **Course Grading Information:**

1. Attendance/Participation: Being present both physically and mentally is prime.

10% of total grade.

2. Briefs: Written 6-10 page brief over selected playwright, period, event, or production style.The brief will be orally presented.20% of total grade.

3. Play report: Student will select a specific play from the periods covered in the course. The report will summarize the plot and address the key thematic issue while commenting on the historical impact of the work itself. 10 % of total grade.

4. Exams: Students will four exams. Each exam is worth 20% of the total final grade. The lowest exam grade will be dropped. Exams will consist of written essays. Study aids for each exam will be provided during class. 60% of total grade.

### Late Work, Attendance, and Make Up Work Policies:
