Course Description:

Individual instruction in voice or brass, percussion, woodwind, stringed, or keyboard instruments. Available to non-majors as well as music majors who wish to study a secondary applied emphasis. Involves one private lesson per week and five practice hours per week. May be repeated for credit.

Course Notes and Instructor Recommendations:

The purpose of this class is twofold:

1. To provide private instruction on flute and piccolo to music majors in partial fulfillment of degree requirements in music and music education, and
2. To provide private instruction on flute and piccolo to those outside the music department who wish to improve their performance on their chosen instrument

All required music for study will be selected by the instructor from technique books and solos appropriate to the student's individual level of development on the flute. Flute World, Carolyn Nussbaum Co, and JW Pepper have competitive prices.

Methods of Teaching and Learning:

Assignments will be made for each lesson and mastery of the assignments will be evaluated at the following lesson. Assignments will include technical studies, literature, listening, and some reading.

Students should bring to lessons the following items:

- Flute and/or piccolo in good working order; no leaks, etc.
- Metronome and tuner with drone function
- All assigned music and any other music with which the student might need assistance.
Photocopies are acceptable only until music arrives, or for page turns
- Pencil and spiral notebook for taking notes

Course Objectives and/or Competencies:

- The student will be evaluated at the beginning of the first semester of study and appropriate materials will be selected for study.
- The student will meet for sixty minutes per week with the instructor at a time arranged at the convenience of both parties. Schedule changes will be communicated via email.
- The student should practice the assigned material a **minimum of ten hours** per week.

Course Outline or Schedule:

One 60 minute lesson each week in the spring and fall semesters to be scheduled at the convenience of both the student and instructor. One hour lesson each week in summer sessions.

Course Grading Information:

Grades will be based on successful completion of:

1. performance of assigned material for each lesson (70%),
2. performance in studio class (5%),
3. performance in Student Recital (10%),
4. performance at Juries (10%),
5. recital attendance (5%), 15 a semester. Submit recital programs to applied teacher. (Each unexcused absence will reduce the final grade by one-half letter)

Late Work, Attendance, and Make Up Work Policies:

- All lessons are required. Each unexcused absence will reduce the final grade by one-half letter.
- A student is required to notify the teacher of an anticipated absence. A make-up should be scheduled by the student at that time, or as soon as possible. A missed make-up by the student will not be rescheduled, will not be made up, and will be counted as a missed lesson.
- No more than two makeup lessons per semester are allowed.
- Lessons will not be made up if the student is not prepared or has been dismissed from the lesson for lack of preparation of the assigned material.
- Cancellations day-of will not be made up.
- Attendance is required at all student and Departmental recitals.
- Attendance is required at each Woodwind Studio Class, Thursdays 3-4pm.
- Each unexcused absence at any of these required events will reduce the final grade by one-half letter.

Student Behavioral Expectations or Conduct Policy:

The student is expected to arrive at the lesson on time and with the appropriate instrument in good working order. The assigned materials should be prepared as instructed. Repeated unpreparedness, a poor attitude, or poor etiquette (improper dress, improper language, etc.) will result in dismissal from the lesson.
