  - b) Demonstrate the procedure for setting up amplifiers and sound systems.
  - c) Develop basic concepts at stage appearance and showmanship.
    - 1) Stage Position
    - 2) Announcements to the Public
    - 3) Personal Image
    - 4) Attire or Costume
  - d) Learn basic production skills relating to the organization and rehearsal of a country band.
  - e) Learning the "Nashville Number System" for charting songs.
  - f) Learn to perform 15-20 songs representing the major country music styles.

#### **Course Outline or Schedule:**

Class meets M.W.11:05 -12:00 T. TH. 8:00-9:00

#### **Course Grading Information:**

Student's grades will be based on, preparation 33%, rehearsal 33% and performance 34%. Mastery of material will be demonstrated in class rehearsals and performances.

#### Late Work, Attendance, and Make Up Work Policies:

Regular and punctual attendance is expected of all students, and each instructor will maintain a complete record of attendance for the entire length of each course. Students will be counted absent from class meetings missed, beginning with the first official day of classes. Students, whether present or absent, are responsible for all material presented or assigned for a course and will be held accountable for such materials in the determination of course grades. In the case of online and hybrid courses, attendance will be determined in terms of participation, as described in the course syllabus.

Absence from 25 percent of scheduled lecture and/or laboratory meetings will be taken as evidence that a student does not intend to complete the course, and the student will be withdrawn from the course with a grade of W. The instructor may reinstate the student if satisfied that the student will resume regular attendance and will complete the course. If the student's 25 percent absences are reached after the official drop date, the instructor may assign a W, if the student is passing and requests to be withdrawn. However, if a student who is not passing reaches the 25 percent point after the official drop date, the student will receive an F. In extenuating circumstances, the instructor may assign a W to a student who is not passing.

Each absence will count toward attendance requirements in each course.

Students will be permitted to make up class work and assignments missed due to absences caused by (1) authorized participation in official College functions, (2) personal illness, (3) an illness or a death in the immediate family, or (4) the observance of a religious holy day. Also, the instructor has the prerogative of determining whether a student may make up work missed due to absences for other reasons. It is the student's responsibility to inform the instructor of the reason for an absence and to do so in a timely fashion.

#### **Student Behavioral Expectations or Conduct Policy:**

Students are expected to maintain classroom decorum that includes respect for other students and the instructor, prompt and regular attendance, and an attitude that seeks to take full advantage of the educational opportunity.
