# **Course Objectives and/or Competencies:**

Students will rehearse together twice a week in preparation for the semester performances, which includes the final concert at the end of the term.

## **Course Outline or Schedule:**

Students will memorize vocal parts weekly for each song selection and bring to performance level all song material. Students will participate in improvisation exercises as lead by the instructor and will demonstrate willingness to improvise.

## **Course Grading Information:**

Students will receive a grade for each class attended, based on their part preparation and willingness to participate effectively in the improv exercises. Punctuality and attitude will also figure into the grade. Students who miss more than once will have their grade dropped by one letter for each absence.

## **Late Work, Attendance, and Make-Up Work Policies:**

Students will be graded according to attendance. Due to the nature of the course, regular attendance is mandatory. Three absences constitute grounds for removal of the student from the course by the instructor. Parts must be learned for the next rehearsal, regardless of whether or not the student missed the prior meeting.
