Competencies to be Selected from the Following:

- 1.) Synthesizer terminology.
- 2.) Synthesizer programming.
- 3.) MIDI specifications and protocol.
- 4.) MIDI sequencing and editing. This competency covers a wide range of applications depending on the type of sequencer the student wishes to master and the level of skill previously attained by the student.
- 5.) Drum machine programming.
- 6.) MIDI signal processors.
- 7.) MIDI synchronization between multiple MIDI devices, tape decks, and/or video.
- 8.) Music notation through converting MIDI sequences to Finale.

Other competencies may be selected at the instructor's discretion depending on the student's skill level, equipment, or specific needs.

The final grade for this course will be the average of all weekly grades earned by the student at each individual lesson throughout the semester. Attendance may affect the student's final course grade (see below).
