#### **Learning Outcomes**

Upon successful completion of this course, students will:

- 1. Read, analyze, and critique religious texts.
- 2. Demonstrate knowledge of diverse beliefs, practices, and values of selected religious traditions.
- 3. Trace and present orally or in writing the origin and historical developments of selected religious traditions.
- 4. Communicate understanding of selected religious traditions, orally or in writing.

Discuss ways of living responsibly in a world where people have diverse religious beliefs.

#### **Course Outline or Schedule:**

Each section of the class will include readings, reading quizzes, and participation in a Discussion Board.

- Section 1. Introductory Matters: Canons, Texts, Geography, Cultures. The Pentateuch
- Section 2. The Former Prophets
- Section 3. The Latter Prophets
- Section 4. The Writings
- Section 5. Persian-Era Prophets. Apocrypha.
- Section 6. The Gospels
- Section 7. Acts. The Epistles. The Revelation.

#### **Course Grading Information:**

- 15 Reading Quizzes @ 20 points each = 300 points
- 7 Discussion Boards = 140 points
- Reflection Essay = 30 points

Reading Quizzes will consist of "objective" questions such as multiple choice, etc. They will be open book, but timed. You will need to master the material before you take the quiz. There are 16 Reading Quizzes, but the grading scale assumes fifteen because now and then internet connection might be lost. If you take all sixteen RQs, then the score of the sixteenth serves as extra-credit points. Courses are open book, but timed.

Discussion Board evaluation will be done both on meeting the requirements and quality...

Reflection Essay will be evaluated for thoughtfulness as you give careful consideration to the suggested questions on the content of the class.
