Course Description:

Introduction to the basic elements of music theory for music and non-music majors: scales, intervals, keys, triads, elementary ear training, keyboard harmony, notation, meter and rhythm. (Does not apply to a music major degree.)

Prerequisites and/or Corequisites:

No prerequisites are required for this course

Course Notes and Instructor Recommendations:

1. Pencil and notebook to take notes given by instructor

2. Reading at the college level means the ability to analyze and interpret a variety of printed materials -- books, articles, and documents. A core curriculum should offer students the opportunity to master both general methods of analyzing printed materials and specific methods for analyzing the subject matter of individual disciplines.

3. Students will be asked to write in correct notation on the board as a group activity with the rest of the class.

4. Students will be taught how to properly read and identify musical notations.

5. Students are required to opt-in to Brightspace by week one (1) to receive notifications.

Methods of Teaching and Learning:

Two weekly lectures in which the instructor will begin with introducing basic musical notation and give demonstrations on identifying notation.

The basic plan for each learning unit is the following:

1. You will read/watch the initial instruction

2. You will perform various activities/practice assignments and quizzes to gain proficiency and understanding of the material, and finally...

3. You will complete graded quizzes and assignments to demonstrate mastery of skills and concepts.

4. Occasionally, you will be asked to demonstrate, orally or physically (on a piano keyboard), previously learned skills, knowledge, and activities in real-time to show retention and competency.

Course Objectives and/or Competencies:

Fundamentals of Music is designed to provide students with fundamental skills, both written and aural, in preparation for further musical study. This course is the foundation for all studies in music theory. The course includes notation, rhythm, major and minor scales, key signatures, intervals, and triads. Additional skills include dictation, sight singing, and familiarity with the piano keyboard. Upon successful completion of this course, students will be able to:

- 1. Understand elements of musical notation
- 2. Identify and notate intervals, scales, and triads
- *3. Comprehend ear training examples*
- 4. Find intervals, scales, and chords on a piano keyboard
- 5. Recognize and properly notate rhythmic patterns

Course Attendance/Participation Guidelines:

If a student is not in attendance in accordance with the policies/guidelines of the class as outlined in the course syllabus as of the course census date, faculty are required to drop students from their class roster prior to certifying the respective class roster. A student's financial aid will be re-evaluated accordingly and the student will only receive funding for those courses attended as of the course census date.

Course Grading Information:

Grades will be calculated as follows:

- Homework, daily grades, and class participation 40%
- Module Tests 40%
- Final Exam 20%

If you have a 92+ average on tests and homework, you may be exempt from the final exam (at the discretion of the instructor). Begin thinking about this NOW! Homework must be turned in on time to fulfill this requirement.

Late Work and Make-Up Work Policies:

Homework assignments will incur a 10% deduction for each class period that they are late. Assignments will not be accepted more than two class periods (one week) late. All homework about a unit must be turned in before the test for that unit to receive credit. You cannot realistically expect to pass this class without doing the coursework. Remember that each new concept is based on the understanding and mastery of previous concepts. Drill and repetition are essential to that mastery.

* Exceptions can be made due to illness or emergencies. Please contact the instructor before the assignment due date for assistance*

Students are required to attend a minimum of 75% of lectures to prevent being dropped/or for absences not to negatively impact their progress and grades. Due to class meetings once a week, students are allowed up to seven (7) absences before the instructor is required to drop (W) on the eighth absence. If a student has reached their drop limit of six (6), the instructor is required to issue a failing (F) grade if a student fails to attend 75% of lectures.

Make-up work opportunities will be given throughout the semester to allow the student to review previous materials and improve grades.

Extra credit assignments will be offered throughout the semester. These assignments may include but are not limited to transcribing additional music.
