## HISTORY OF AMERICAN

### MUSIC MUSI 1310\_O081

#### **Course Description:**

A survey of the evolution of jazz, blues, latin, country and rock styles, contributions of important performers, and musical techniques involved in the creation and performance of blues based music. This course will introduce students to the History of American Music (The trail of the Blues), as it evolved in the United States and spread throughout the world. In addition to the historical perspective, internet discussion boards will focus on aesthetic and sociological issues that have influenced the various developments within the genre. Mr. Kutz will share his own personal experience as a musician and try to convey the artistic sensibility that is inherent in all artists and styles.

#### **Course Objectives and/or Competencies:**

This course will provide the student an opportunity to;

---become familiar with the sound of the many variants that are grouped under the heading "rock and roll", focusing primarily on American & British performers in the categories of Jazz, Blues, Country, R&B, Gospel, Rock 'n Roll, Contemporary Christian, Latin and Rap.

---develop the ability to "LISTEN, "not just hear" when participating in the musical experience.

- acquire a musical vocabulary that will enable concise, intellectual discussion about any music.
- gain experience in communicating with others about music, clearly expressing one's own opinions and beliefs.
- learn about individuals integral to the evolution of rock music (e.g., composers, performers, etc.), circumstances surrounding their lives, and style elements common to the various sub-genres.
- gain a historical perspective including listening to and discussing primary musical, social, and aesthetic influences on the emergence & development of rock music.
- apply newly-acquired knowledge about music to unfamiliar contexts.
- identify musical examples from repertoire covered in this course to illustrate the various concepts presented and discussed in class.
- gain a clearer understanding of one's own current musical preferences and the basis for this selection.
- accept the dynamic nature of musical style, realizing that music of tomorrow may require a re-thinking & reformulation of concepts, beliefs, and preferences held today.
- stimulate an appreciation for popular music as a relevant art form within contemporary society and realize the influence that music plays in influencing and shaping society.

#### **Course Attendance/Participation Guidelines:**

If a student is not in attendance in accordance with the policies/guidelines of the class as outlined in the course syllabus as of the course census date, faculty are required to drop students from their class roster prior to certifying the respective class roster. A student's financial aid will be re-evaluated accordingly and the student will only receive funding for those courses attended as of the course census date.

Before the 60% point of the semester, a student who is absent for 25% or more of a face-to-face or blended course or who misses 25% or more of assigned work for an online course will be withdrawn from the course with a grade of W. A student may also request to be withdrawn with a grade of W before the 60% point of the semester. After the 60% point of the semester, the student may request to be withdrawn if the student is passing, or be assigned the final grade earned at the end of the semester after grades have been updated to reflect missing work.

#### **Course Outline or Schedule:**

The course in a nutshell:

- This is a 16 week course. We will complete one unit per week.
- No book, no reading!
- Watch a video, fill out a study guide and take a quiz.
- Use Youtube to find videos of artists for our discussion boards.
- Be prepared to spend at least 3 hours a week on this class during the Fall and Spring terms and 10 hours per week during the summer terms.

—You will need access to Netflix during the last 2 units of the class.

--- The main documentary series: SoundBreaking and Sonic Highways will be made available to you.

---All other documentaries are on Youtube.

***The due dates for all work are due on a Weekly basis.*** Discussion Board (DB) main responses are due by midnight Thursday. Two quizzes per week are due by midnight Sunday as well as 3 DB responses. I allow for quiz make-ups but remain firm on due dates for all DB posts.

**VIDEO LECTURES-** (50% of your grade) These documentaries are located in various places: You can stream or purchase some from Amazon, view others on Youtube, Netflix or Dropbox. You are to view each program and then fill out the outline. There are 2 videos per week in the fall and spring semesters and 6 videos per week in the summer terms. These will cover the entire spectrum of American Music. There is a documentary on **Jazz**, a 4 part series on **Country Music**, a two part series on the **Blues**, a two part series on **Latin Music**. **SoundBreaking** is a 10 part documentary series made by PBS. **Sonic Highways** is an 8 part series made by rock musician **Dave Grohl**. We will watch a 4 part series on Netflix called **Rap Evolution**. Also included are overviews of decades from the 50's through the 90's. **There is overlap of alot of the material**, but that will help you see what is important and reinforce what happened in each decade.

**Warning: In the Hip Hop Evolution series and Sonic Highways series there is some curse language being used by our rock and rap pioneer friends. My apologies, but the depth and scope of these series makes up for those who are using the "King's English." If this is offensive to you and you feel that you are forced to listen to this and want to complain, please consider dropping the course. (This is no worse than your average cable channel or Hollywood movie.)**

**Netflix** The last 2 units require access to Netflix. All other video lectures will be on **Youtube**. These links are available throughout the course!

**DISCUSSION BOARDS-** (30% of your grade) You are **required** to participate in the weekly Discussion Boards (DB) that will focus on relevant topics of the week. There is two DB per week in the fall and spring semesters and 3 DB's per week in the summer terms. You are required to make a 200-400 word post and then read other classmates posts and respond to 3 of them. Short generic posts that appear rushed will not be counted. I read them all and try to respond to them. I consider this part of the course very important because you will form opinions about subject matter and get to know the famous performers of each musical decade. DB's must be completed on a weekly basis. Completing all DB's late (after a week is over) or on the last class day is not allowed. I will grade DB posts and there will be a grade in the grade book for them along with teacher comments.

**Feel free to post earlier with main posts and responses, dates given are the latest acceptable dates and times. The earlier you and others post, the easier it becomes for all of us. Feel free**

**to do more, your effort will be recognized at the end of the term!**

**The rules for posting;** Make a main response by midnight Thursday and make a total of 3 responses to other student posts the last 3 days of the week. To be clear, that is 4 total posts per assignment. (8 week courses will have two DB's per week.) (In the summer terms there are 3 DB's per week and the due date varies, depending on which day of the week the term begins.) This will help make the DB a discussion and not just responses at the last minute. DB's are due by 11:59pm the last day of the week. Also, there is a word minimum and maximum so students don't write too much or too little. The requirement is 200-400 words per main post. Responses should be at least 100 words, so pick responses that inspire you to write!

### **Course Grading Information:**

---Video Lecture quizzes may be taken two times and =50% of your grade.

---Discussion Board posts are graded and= 30% of your grade.

---Midterm exam covers about 14 video lectures and can be taken only once= 10% of your grade

---Final exam cover about 14 video lectures and can be taken only once= 10% of your grade.

### **Late Work, Attendance, and Make Up Work Policies:**

I allow make ups for all quizzes as follows:

---Quizzes for unit's 1-7 can be taken or made up until the midterm period is over, then unit's 1-7 are turned off.

---Quizzes for unit's 8-14 can be taken or made up until the last day of class for the semester.

I DON'T ACCEPT THE DB'S TO BE MADE UP LATE.

Sometimes life gets in the way of a semester, please notify all of your professors of life changing events and let us try to accommodate your needs as best we can. If a grade of incomplete is given, you have a semester to get it made up.

Since we meet face to face, most of our interactions are done in class and on the Discussion Board. Please be respectful of others when responding in class and in discussion board postings. Please treat others with respect. I can and will remove any DB posts that are offensive in any matter. If there is a situation with another student please contact me ASAP so it can be resolved.
